#### MATTERS ARISING

- (a) Billy reported that the County Championships had taken place successfully, with a reasonable entry taking into account the need for a change of date and venue. Thanks were recorded to Billy for taking on the organisation
- (b) Mike reported on the mixed results of Yorkshire teams in the Inter-County Championships. It was agreed that we await notification of the arrangements for the ICC next season before deciding whether to enter teams
- (c) Initial problems about the change of website provider and the Yorkshire Squash domain to Gridhost Ltd. seemed to have been resolved, thanks to Mike Robinson

#### ACTION PLAN EOR 2019-20

- (a) It was agreed that the following competitive activity would be organised in 2019-20 -
  - Yorkshire League (Billy Hawes)
  - Senior/Masters Championships at Pontefract on 25/26 January, with a reserve date of 23/24 November (Billy Hawes)
  - Junior Championships at Pontefract on 28/29 September (Steve Ridge)
  - County Racketball Championships at Chapel Allerton in 2020 (Peter Edwards)
  - Entry of teams in the Inter-County Championships 2019-20 (Steve Ridge, Nicky Horn, Mike Clemson and Peter Edwards)
- (b) It was agreed that the Chairman would arrange to meet Derek Norris to discuss his role in relation to the Northern Cup and the Ridings tournament, and his remit as County Junior Development Officer
- (c) It was agreed that the Chairman would contact Andy Murray (Iprosports) about the quality and price of the proposed new county T shirts, following which the Committee would need to decide on the level of subsidy
- (d) The proposals for supporting and promoting Coaching and Refereeing were agreed
- (e) After considerable discussion, it was agreed to advertise for a (fee) paid Development Officer to work with individual venues in the county to promote the use of their squash courts, and to undertake such other activities as were consistent with our Strategy and Action Plan, and to establish a panel to consider the responses and subsequent action
- (f) The Further Activity listed in the Action Plan was approved
- (g) Steve Ridge would discuss with Jayne Robinson any action arising from a proposal to run a county event for teams from primary schools
- (h) Venues and coaches would be encouraged via the newsletter to consider appropriate action in respect of World Squash Day (12 October) and Womens Squash Week (23-29 September)
- (i) Proposals to run On Court Pressure and Resilience Workshops for Juniors; and Club Matters Workshops for Affiliated Clubs, were noted
- (j) Participation figures, county by county, relating to the England Squash Participation Programmes, had been circulated to Committee members and were noted
